Pursuant to regulation 30 of Listing Regulations, we wish to inform you that in terms of Order issued by Government of India/State Government/Local Administration for containment of COVID-19 in the country, directing lock down in the entire country/cities w.e.f. 23rd March, 2020, and in compliance of the same Manufacturing activities of the Company were shut down at below manufacturing facilities

1. Village: Mota Borasara, Kim, Taluka: Mangrol, Dist.: Surat,

2. Village: Karanj, Limodara Patiya, Taluka: Mandvi, Dist.: Surat

3. Village: Mahuvej (Kosamba) Taluka: Mangrol, Dist.: Surat and

4. Village: Sachin, Dist. Surat, Gujarat,

AND administrative works at Surat Offices

w.e.f. 23rd March, 2020 to till 25th March, 2020. The same was further extended till 14th April, 2020. The same was again further extended till 3rd May, 2020. The duration of this shut down will depend upon directions to be further issued by the respective government authorities in this regard.

However, Government declared detailed agenda for hotspot areas and partial withdrawal of lockdown period after 20th April, 2020. Accordingly, the management has decided to extend the shutdown period for Surat offices till 3rd May, 2020. However, the manufacturing plants operations will partially be resumed from Monday, 27th April, 2020 in compliance with guidelines issued by the Government.

Further, the Company has also implemented Work from Home for all its employees to the extent possible, as per COVID guidelines. The production shut down as above of the manufacturing facilities of the Company will have financial impact which is not ascertainable at this stage.
