PROCEEDINGS OF THE 12TH ANNUAL GENERAL MEETING OF THE MEMBERS OF SHAHLON SILK INDUSTRIES LTD. HELD AT 11:00 A.M. ON SATURDAY, THE 26TH DAY OF DECEMBER, 2020 THROUGH VIDEO CONFERENCING ("VC")/ OTHER AUDIO VISUAL MEANS ("OAVM") AND CONCLUDED AT 11:26 A.M.

Directors present through VC/OAVM were introduced themselves and Mr. Dhirajlal R. Shah, Chairman of the Company was presided over the meeting.

As the requisite quorum was present, the Chairperson called the meeting in order and welcomed the members.

The Statutory Auditor and Secretarial Auditor of the Company were also present in the meeting through VC/OAVM. Since there was no physical attendance of Members and in compliance with the Circulars issued by the MCA and SEBI, the requirement of appointing proxies was not applicable, except for the authorized representatives of corporate shareholders. The Chairperson, with the consent of the members present, took the Notice of the 12th Annual General Meeting and the Directors' Report as read. The Company Secretary informed the Members that the Statutory Auditors' Report did not contain any qualifications, other reservations, adverse remarks or disclaimers AND Secretarial Audit Report is selfexplanatory and do not call for any further explanation/comments.

The Chairperson has delivered his speech on the Company's performance and impact of COVID-19 Pandemic on Indian Economy and Textile Industries.

The Chairperson informed that there was no query/ questions raised by any members.

The Chairperson further informed that pursuant to Section 108 of the Companies Act, 2013 read with Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided the remote e-voting facility to its members to cast their vote electronically on all the Resolutions set out in the Notice of the 12th Annual General Meeting from 23rd December, 2020 (9.00 a.m.) to 25th December, 2020 (5.00 p.m.). The Company had engaged the services of Central Depository Services (India) Limited (CDSL) to provide remote e-voting facilities.
